Explanation of Responses:

(1) The shares were contributed by the reporting person to an irrevocable trust, for which there is an independent, third-party trustee, for the benefit of the reporting person's family. The reporting person disclaims beneficial ownership of the shares.

(2) The shares were contributed by the reporting person to a charitable foundation. The reporting person is a member of the Board of Directors for the charitable foundation and has both investment control and voting power for the foundation. The reporting person disclaims beneficial ownership of the shares.

(3) On March 8, 2000, the Company issued an additional 60,000 shares of Class A Common Stock to EchoStar Communications Corporation's 401(k) Employees' Savings Plan (the "Plan"). The number of shares reported in column 5 represents the total number of shares allocated to the reporting person's account through the Plan to date. The reporting person has dispositive, but no voting power with respect to the shares.

(4) The shares are held by the reporting person in trust for the benefit of the minor children of Charles W. Ergen, the Chief Executive Officer of the Company. The reporting person disclaims beneficial ownership of the shares.

(5) The shares are held by the reporting person as custodian for his minor children.
