Item 1. Security and Issuer.

The title of the class of security to which this statement relates is the Common Stock of Tengasco, Inc., whose principal executive offices are located at 603 Main Ave., Suite 500, Knoxville, TN 37902.

Item 2. Identity and Background

This statement is filed by Peter E. Salas, a United States citizen with a business address at Dolphin Asset Management Corp., 129 East 17th Street, NY, NY 10003, as General Partner of Dolphin Offshore Partners, L.P. His present principal occupation is General Partner of Dolphin Offshore Partners, L.P. During the last five years, Mr. Salas has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) nor been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction subjecting him to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, Federal or State securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration

400,000 shares were received from an escrow account securing a put option and 24,000 common share options were received.

Item 4. Purpose of the Transaction

The shares were acquired for investment purposes only.

Item 5. Interest in Securities of the Issuer

Mr. Salas is the beneficial owner of 2,139,720 common shares, \$900,000 face value of 8% Series B Preferred, convertible into 117,188 shares, 10,500 common stock warrants, a \$500,000 note, convertible into 173,611 shares and an option for 24,000 common shares.

Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer

Mr. Salas has the exclusive right to vote the shares of Common Stock at any regular or special meetings of the shareholders of the Company and/or any actions in lieu of meetings or shareholder proceedings.
