Explanation of Responses:

1. Represents the value of the Reporting Person's Stock Fund Account in the Company's 401(k) plan as of October 31, 2001, expressed as share equivalents. As of such date 95.18% of such fund was invested in Company Common Stock.
2. Represents shares of restricted stock granted to the Reporting Person on October 23, 1997 under the Issuer's Long Term Stock Incentive Plan as follows: (i) 1,771 shares which may vest over a five-year period, and (ii) 8,961 shares which may be earned for the five-year performance period ending December 31, 2001 subject to the achievement of performance goals, 50% of which may be distributed when earned and 50% of which may be distributed over a five-year period commencing on the date earned.
- 2A. On October 8, 2001, 2,987 shares of restricted stock vested under the Issuer's Long Term Stock Incentive Plan. On that date, the Company purchased all of these vested shares pursuant to Rule 16b-3(e).
3. Reflects shares allocated to the Reporting Person's account under the Company's Salary and Bonus Deferral Plan.
4. Represents amounts allocated to, and the total holdings in, the Reporting Person's Company Stock Fund Account in the Company's Supplemental Savings and Investment Plan as of October 31, 2001, expressed as share equivalents. Because the trustee and record keeper for this plan utilize unit accounting for the Company Stock Fund rather than share accounting, these amounts represent share equivalents allocated to the Reporting Person's account rather than shares of Common Stock.

5. Represents an option granted to the Reporting Person on December 6, 1996 under the Issuer's Long Term Stock Incentive Plan to purchase 5,000 shares of the Issuer's Common Stock at \$19.00 per share.
6. Represents an option granted to the Reporting Person on May 18, 2001 under the Issuer's Long Term Stock Incentive Plan to purchase 25,000 shares of the Issuer's Common Stock at \$16.87 per share.
