For the three months ended September 30, 2003, Registrant incurred a net loss of approximately \$468 thousand on revenues of approximately \$1.279 million. For the three months ended September 30, 2002, registrant incurred a net loss of \$410 thousand on revenues of \$1.425 million. The primary reason for the decrease in revenues was decreased PeopleMed.com revenues and decreased implementation fees that were partially offset by an increase in maintenance revenues. The net loss increased primarily because of the decrease in revenues of \$146 thousand partially offset by a

decrease in financing costs of \$63\$ thousand from the comparable period in 2002.

For the nine months ended September 30, 2003, Registrant incurred a net loss of approximately \$401 thousand compared to a net loss of \$537 thousand for the nine months ended September 30, 2002. For the nine months ended September 30, 2003 and 2002, Registrant recognized revenues of \$5.097 million and \$4.838 million, respectively. The primary reason for the decrease in the net loss is the increase in revenues of \$259 and a decrease in financing costs of \$64 thousand, which were partially offset by an increase in operating expenses of \$155 thousand for the nine months ended September 30, 2003 compared to the similar period in 2002.
