This Certificate of Notification (the "Certificate") is filed by Energy East Corporation ("Energy East"), a New York corporation and registered holding company under the Public Utility Holding Company Act of 1935, as amended (the "Act"). The transactions proposed in the Form U-1 Application, as amended (the "Application") of Energy East in File No. 70-9609 were authorized by Order of the Securities and Exchange Commission (the "Commission") dated September 12, 2000, (the "Order"). Energy East hereby certifies the matters set forth below pursuant to Rule 24 of the rules under the Act for the period April 1, 2002, through June 30, 2002.

Under the Dividend Reinvestment Plan, 176,138 shares of Energy East common stock were issued, substantially out of treasury stock. Under employee benefit plans, 17,300 shares of Energy East common stock were purchased in the open market. Under options granted during the quarter, 184,300 shares of Energy East common stock were issuable during the quarter.

Energy East issued 27,509,320 shares of its common stock in exchange for 45% of the common stock of RGS Energy Group, Inc. in June 2002.

The Southern Connecticut Gas Company (Southern) issued short-term debt in the form of a bank credit facility during the quarter ranging from \$6.0 million to \$18.0 million, at interest rates ranging from 2.40% to 2.46%, and with a maximum amount outstanding of \$18 million.
