ITEM 12. RESULTS OF OPERATIONS AND FINANCIAL CONDITION.

On April 7, 2004, Metron Technology N.V. (Metron) reported its fiscal third quarter results for the period ended February 29, 2004. A copy of the press release issued by Metron on April 7, 2004 concerning the foregoing results is furnished herewith as Exhibit 99.1 and is incorporated herein by reference.

Metron provides pro forma net loss, pro forma net loss per share and pro forma inventories in the press release as additional information for its operating results. Metron s management believes that the presentation of these measures provides useful information to investors regarding certain additional financial and business trends relating to its financial condition and results of operations. These measures are not in accordance with, or an alternative for, generally accepted accounting principles and may be different from pro forma measures used by other companies. The calculations of pro forma net loss and pro forma net loss per share have been adjusted to exclude the effects of a restructuring charge. The calculation of pro forma inventories has been adjusted to exclude inventory for delivered equipment that pertains to deferred revenue.
