(1) SHARES WITHHELD BY REGISTRANT TO SATISFY MINIMUM STATUTORY WITHHOLDING REQUIREMENTS ON VESTING OF RESTRICTED STOCK UNITS.

(2) The option vests in 4 year vesting schedule, 25% on November 15, 2012 and 1/36th of the remaining option to vest each month thereafter.

(3) Each performance right represents a contingent right to receive one share of Sanmina-SCI common stock.

The performance rights vest as to 1/3 of the shares subject thereto if, the Company's closing stock price equals or exceeds \$11.00 per share upon the first anniversary of the date of grant (the "Threshold Condition").
