On June 26, 2013, Air Lease Corporation (the Company ) issued \$132,046,000 aggregate principal amount of its 5.625% Senior Notes due 2017 (the new notes ) in connection with its offer to exchange up to \$151,614,000 aggregate principal amount of new notes for any and all of its outstanding 7.375% Senior Unsecured Notes due January 30, 2019, pursuant to a Senior Notes Indenture, dated as of March 16, 2012, as supplemented by a Supplemental Indenture, dated as of June 26, 2013, by and between the Company and Deutsche Bank Trust Company Americas, as Trustee. The Company filed a registration statement on Form S-4 (File No. 333-188716) with the Securities and Exchange Commission with respect to the offering of the new notes.
