LIMITED POWER OF ATTORNEY

THIS LIMITED POWER OF ATTORNEY given on the 16th day of July, 2015 by CVI Investments, Inc. (hereinafter called the Company), whose Registered Office is situated at PO Box 309GT, Uglan House, South Church Street, George Town, Grand Cayman, Cayman Islands.
