Overnight Trading Volumes Set New Records on Election Night

> The Tuesday overnight trading session set record volume in a number of CBOE products. The night s jump in non-U.S. trading hours volume followed a drop in global market prices as the results of the U.S. Presidential Election began to favor a Donald Trump victory over a previously expected win by Hillary Clinton.
VIX Futures
> On November 9, volume in futures contracts on the CBOE Volatility Index (VIX Index) set a new record of 263,663 contracts during non-U.S. trading hours. This record surpassed the previous high of 235,141 contracts set during the overnight session on June 24, 2016, when U.K. voters decided that Britain should leave the European Union, an event also known as Brexit.
SPX and VIX Options
> Also on November 9, S&P 500 Index (SPX) options and VIX options combined set a new record in non- U.S trading hours with 108,015 contracts traded. This total included a record 41,218 contracts in SPX options (including SPX Weeklys).
> Additionally, on Friday, November 4, volume in VIX options set a new record of 89,322 contracts during non-U.S. trading hours.
