Shares of deferred stock not credited to the stock unit account because of termination as a director before the end of the director's term are forfeited.
 - (2) Includes 7,691 shares of deferred common stock deliverable upon termination as a director under the Monsanto Company Non-Employee Director Equity Incentive Compensation Plan; 66 shares of common stock issued as dividends with respect to such deferred shares; 4,000 shares of common stock owned directly by the Reporting Person and 3,000 shares of restricted stock which will vest in full on May 4, 2007, subject to the terms and conditions of the Monsanto Company Long-Term Incentive Plan.
