(1) On July 17, 2013, Mr. O'Keefe was awarded 627,632 shares of Class A common stock pursuant to the Artisan Partners Asset Management Inc. 2013 Omnibus Incentive Compensation Plan. The shares may not be transferred until they have vested. In general, twenty percent of the award will vest on August 1 of each of 2014, 2015, 2016, 2017 and 2018. Mr. O'Keefe is an employee-partner of Artisan Partners Asset Management's subsidiary, Artisan Partners Holdings LP.
