At or above the minimum level of performance, the actual number of shares earned may range from 0% to 150% of the target award amount.

The award is eligible to vest at 45% of the target award amount based upon the Issuer's achievement of certain performance criteria based on EBIT growth and return on invested capital during a two year performance period.
