Item 2.02 Results of Operations and Financial Condition.

On April 30, 2009, Black Hills Corporation (the Company) issued a press release announcing first quarter financial results for 2009. Net income for the three months that ended March 31, 2009, was \$26.4 million, or \$0.68 per share, compared to net income of \$16.8 million, or \$0.44 per share for the same period in 2008. Income from continuing operations for the first quarter 2009 was \$25.6 million, or \$0.66 per share, compared to income from continuing operations for the first quarter 2008 of \$11.8 million, or \$0.31 per share.
