Represents shares of common stock underlying restricted stock units granted to the reporting person under the Royal Caribbean Cruises Ltd. 2008 Equity Incentive Plan. Award vests in as follows: 25% on first anniversary of grant date and 75% April 12, 2015, the reporting person's 63rd birthday. Notwithstanding the foregoing vesting schedule, the shares vesting on April 12, 2015 will be subject to restrictions on transferability which will lift with respect to one-third of the underlying shares vesting on such date on each of the second, third and fourth anniversary of the grant date.

(2) Granted in consideration for service as an officer of the issuer.

Represents shares of common stock underlying performance shares granted to the reporting person under the Royal Caribbean Cruises Ltd. 2008 Equity Incentive Plan. The target award was authorized by the Board of Directors on February 8, 2013. The actual number of shares underlying the award was determined by the Compensation Committee on February 5, 2014 based on the Company's Return on Invested Capital for the year ended December 31, 2013. The award vests in one installment on February 8, 2016.
