- (1) On January 4, 2017, the Issuer entered into an agreement with Charles D. Urstadt (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 1,050 shares of Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- This figure includes 5,050 restricted shares of Common Stock issued pursuant to the Restricted Stock Award Plan. On January 3, 2017, restrictions applicable to a previously reported grant of 950 shares of Common Stock lapsed, resulting in the reporting person becoming fully vested in such shares. - (2) Realty Associates Co LP ("URACO"), of which the Charles D. Urstadt Irrevocable Trust (the "CDU Trust") is a limited partner. The Reporting Person is the sole beneficiary of the CDU Trust.
