This Amendment No. 2 to Schedule 13D ("Amendment No. 1") amends the Schedule 13D filed by S-ParkerWilf Family Limited Partnership ("S-PFLP"), S-ParkerWilfCo., Inc. ("S-General Partner") and Stacie Wilf ("Wilf" and, together with S-PFLP and S-General Partner, collectively referred to as the "Reporting Persons") with respect to ownership of the common stock of ParkerVision, Inc.

The percentage of beneficial ownership reflected in this Amendment No. 2 is based upon 17,959,504 shares of Common Stock outstanding as of February 25, 2004.

ITEM 1. SECURITIES AND ISSUER

The class of equity securities to which this statement relates is the common stock, par value \$.01 per share ("Common Stock"), of ParkerVision, Inc. ("Issuer"), a Florida corporation, whose principal executive offices are located at 8493 Baymeadows Way, Jacksonville, Florida 32256.

ITEM 2. IDENTITY AND BACKGROUND

S-PFLP's business address is located at 409 S. 17th Street, Omaha, Nebraska 68102. S-PFLP is a limited partnership organized and existing under the laws of Nebraska. The principal business of S-PFLP is to hold certain shares of the Issuer's Common Stock owned by Wilf.

S-General Partner's business address is located at 409 S. 17th Street, Omaha, Nebraska 68102. S-General Partner is a corporation organized and existing under the laws of Nebraska. The principal business of S-General Partner is to act as the sole general partner of S-PFLP. S-General Partner owns 1% of S-PFLP and was formed, and is 100% owned, by Wilf. Wilf is the President and sole Director of S-General Partner.

Wilf's business address is located at 8493 Baymeadows Way, Jacksonville, Florida 32256. Wilf is a director and officer of the Issuer. The Issuer is engaged in the design, manufacture and distribution of automated video camera control systems and D2D wireless technology. Wilf is a citizen of the United States.

None of the Reporting Persons have been convicted in any criminal

proceeding (excluding traffic violations or similar misdemeanors) during the last five years.

None of the Reporting Persons have been a party to any civil proceeding of a judicial or administrative body of competent jurisdiction resulting in any judgment, decree or final order enjoining them from engaging in future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws during the last five years.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

ITEM 4. PURPOSE OF TRANSACTIONS

On February 25, 2004, S-PFLP and Wilf entered into a voting agreement in connection with the execution of an asset purchase agreement entered into by the Company with Thomson Broadcast & Media Solutions, Inc., and Thomson Licensing, S.A. for the sale of the assets of the video business. Under the terms of the voting agreement, the signatories have agreed to vote in favor of the sale of the business and approve the transaction upon submission to the stockholders of the Company. The voting agreement terminates upon termination of the asset purchase agreement.

Other members of the Parker family and their affiliates and one other director of the Company have also signed the voting agreement, who together with the Reporting Persons own approximately 27% of the issued and outstanding shares of common stock of the Company.

Except as discussed above, none of the Reporting Persons have any plans or proposals to effect an extraordinary corporate transaction, such as a merger, reorganization or liquidation involving the Issuer or any of its subsidiaries, cause a sale or transfer of a material amount of the assets of the Issuer or any of its subsidiaries, cause any material change in the present capitalization or dividend policy of the Issuer, cause any other material change in the Issuer's business or corporate structure, cause any changes in the Issuer's charter or bylaws or other actions that may impede the acquisition of control of the Issuer by any person, cause a class of securities of the Issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted on an inter-dealer quotation system of a registered national securities association, cause a class of equity securities of the Issuer to become eligible for termination of registration pursuant to Section 12(g)(4) of the Securities Exchange Act of 1934, or take any other action similar to any of those enumerated above.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER

S-PFLP is the beneficial owner of 905,811 shares of Common Stock of the Issuer. S-PFLP has shared voting and dispositive power over these shares as described below. S-PFLP beneficially owns 5.04% of the Issuer's Common Stock.

S-General Partner is the beneficial owner of 905,811 shares of Common

Stock of the Issuer. S- General Partner, in its capacity of being the sole general partner of S-PFLP, controls S-PFLP. Accordingly, S-General Partner is the beneficially owner of the shares held by S-PFLP. S-General Partner has shared voting and dispositive power over the shares held by S-PFLP. S-General Partner beneficially owns 5.04% of the Issuer's Common Stock.

Wilf is the beneficial owner of 1,033,416 shares of Common Stock of the Issuer. This amount represents (i) 905,811 shares of the Issuer's Common Stock held by S-PFLP, (ii) 29,505 shares of the Issuer's Common Stock owned of record by Wilf, (iii) 10,600 shares of the Issuer's Common Stock held directly by Wilf's children, over which Wilf disclaims ownership, and (iv) 87,500 shares of the Issuer's Common Stock issuable upon immediately exercisable options held by Wilf. Wilf, as owning 98.89% of the limited partnership interests of S-PFLP and 100% of S-General Partner and being the President and sole Director of S-General Partner, controls S-General Partner and S-PFLP. Accordingly, Wilf is deemed to be the beneficial owner of the shares held by S-PFLP and S-General Partner. As a result of Wilf's control of S-General Partner and S-PFLP, Wilf ultimately has sole voting and dispositive power over the shares held by S-PFLP, although it is nominally shared with S-PFLP

as the record owner of the shares, and with S-General Partner which, as sole general partner, controls S-PFLP. Parker beneficially owns 5.73% of the Issuer's Common Stock.

ITEM 6. CONTRACTS, ARRANGEMENTS, UNDERSTANDINGS OR RELATIONSHIPS  
WITH RESPECT TO THE SECURITIES OF THE ISSUER

Wilf has entered into stock option agreements to reflect the stock option grants described herein. On March 26, 2003, Wilf entered into the stock purchase agreement to purchase 49,505 shares of common stock. On February 25, 2004, S-PFLP and Wilf entered into the voting agreement described herein.
