Item 2.02. Results of Operations and Financial Condition.

Ultralife Batteries, Inc. (the "Company") reported results for the first quarter ended April 1, 2006. Operating income for the quarter was \$0.2 million on revenues of \$18.3 million. Included in operating income was stock-based compensation expense of approximately \$0.3 million. In comparison, the Company reported an operating loss of \$1.7 million on revenue of \$15.4 million for the
