- (1) Revlon, Inc., the issuer, completed a 1-for-10 reverse stock split on 9/15/08 in which each 10 shares of the issuer's common stock were combined and reduced to 1 share. Accordingly, the shares reported in this Form 4 are adjusted for the 1-for-10 reverse stock split. On 12/9/08, the reporting person was granted restricted stock covering 10,750 shares of Revlon, Inc. Class A Common Stock under the
- (2) Third Amended and Restated Revlon, Inc. Stock Plan. The restricted stock was not vested on the date of grant. One-third of the shares vest on each of 1/10/10, 1/10/11 and 1/10/12.
- (3) Of the reporting person's other 17,308 shares previously reported as beneficially owned, 3,333 are unvested restricted shares, 833 of which vest on 1/2/09, 833 of which vest on 11/28/09, 833 of which vest on 1/2/10 and 834 of which vest on 1/2/11.
