Item 1.01 Entry Into a Material Definitive Agreement.

On November 30, 2005, Ampal-American Israel Corporation (the Company) entered into an agreement with Shlomo Shalev, the Senior Vice President Investments of the Company, with respect to the termination of his employment with the Company.
