These shares of common stock were acquired pursuant to The Medicines Company Employee Stock Purchase Plan ("ESPP") for the

(1) ESPP purchase period beginning September 3, 2013 and ending February 28, 2013. In accordance with the terms of the ESPP, these shares were purchased based on 85% of the fair market value closing price of the issuer's common stock on February 28, 2014.

(2) These shares of restricted stock vest in 25% increments on each anniversary of the date of grant, until fully vested.

(3) These shares of common stock were withheld for payment of taxes in connection with the vesting of 9,337 shares of restricted stock from a previously reported grant.

(4) The option vests in forty-eight equal installments ending April 1, 2018.
