Restricted Stock Units vest 25% on 4/30/2010; 25% on 4/30/2011 and 50% on 4/30/2013. Stock units will automatically be converted into shares of common stock in accordance with the respective vesting schedule unless a previous deferral election has been made. Stock units are entitled to dividend equivalent rights, which accrue on dividend record dates.
