- (1) The number of shares shown represents the time-based restricted stock units (TBRSUs) that vested and were paid on April 15, 2010. These TBRSUs were awarded on February 27, 2007.  
  
Each restricted stock unit (RSU) represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. RSUs (both performance-related and time-based) are valued as of the date of vesting and are paid 60% in shares of A. H. Belo Corporation Series A Stock and 40% in cash.
- (2) The number of shares shown represents settlement of the 40% cash portion of RSUs that vested and were paid on April 15, 2010. Pursuant to SEC guidance settlement of the cash portion is deemed a disposition of shares to the Company.
- (3) The number of shares shown represents the portion of the December 2006 performance-related restricted stock units (PBRsUs) that vested and were paid on April 15, 2010. These PBRsUs were awarded in December 2006, as described below in footnote 9.
- (4) The reporting person disclaims beneficial ownership of these securities.
- (5) Held by the A. H. Belo Savings Plan as of April 15, 2010.
- (6) These TBRSUs were awarded on February 27, 2007.
- (7) These TBRSUs vest 100% and are paid as soon as practicable following the annual earnings release date for the fiscal year ending December 31, 2009.
- (8) These PBRsUs were awarded in December 2006. The actual number of PBRsUs earned was determined on February 26, 2008.
- (9) One-third of the original PBRsUs vest and are paid as soon as practicable following each annual earnings release date for the fiscal years ended December 31, 2007, 2008 and 2009.
