- This Form 4/A is being filed to amend the number of performance-based restricted shares ("PSAs") issued to the reporting person as
- (1) reported in the original Form 4 filing on March 6, 2014, to reflect 150% of the target amount rather than the originally reported target amount.
Represents PSAs issued to the reporting person under the issuer's 2010 Equity Incentive Award Plan. The number of PSAs earned is based on the issuer's achievement of relative total shareholder return ("TSR") measured versus the MSCI US REIT Index over a three-year performance period ending December 31, 2016, and the number of shares earned may range from 0% to 150%. The PSAs are earned as follows: (i) 20% of the PSAs are earned upon TSR achievement in year one of the performance period, (ii) 20% of the PSAs are earned upon TSR achievement in year two of the performance period, (iii) 20% of the PSAs are earned upon TSR achievement in year three of the performance period, and (iv) 40% of the PSAs are earned upon a cumulative TSR achievement over the three-year performance period, subject to the reporting person's continued employment with the issuer at the end of the three-year performance period. The PSAs are granted and issued at 150% of the target amount.
 - (3) The reporting person is a co-trustee of the family trust.
