Unilever NV also announces that 2,475 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 131,146,473 Unilever NV ordinary shares in treasury, and has 1,583,581,227 Unilever NV ordinary shares in issue (excluding treasury shares).
