Item 1.01 Entry into a Material Definitive Agreement.

On November 30, 2004, AK Steel Corporation entered into a Separation Agreement and Release (the Agreement) with Thomas C. Graham, Jr., its Vice President, Engineering. Under the terms of the Agreement, Mr. Graham voluntarily resigned from all positions with AK Steel Corporation, AK Steel Holding Corporation (the Company) and related entities to be effective December 31, 2004. The Agreement became effective on December 8, 2004.
