### 2007 First Quarter Operating Results

On April 30, 2007, Kookmin Bank held an earnings conference and released its operating results for the first quarter of 2007. The figures for the first quarter of the fiscal year 2007 presented herein are currently being reviewed by our independent auditor, and such figures are subject to change.

In effect from January 1, 2007, we have adopted SKAS<sup>1</sup> No. 21 ( Preparation and Presentation of Financial Statements I ) and SKAS No. 24 ( Preparation and Presentation of Financial Statements II (Financial Industry) ), pursuant to which the presentation and order of certain line items, including gain/loss on disposal of available-for-sale securities, have been reclassified from non-operating income to operating income. We have revised our financial statements for prior periods to effect this change.
