Pursuant to SEC Rule 13d-2, Kaiser Francis Oil Company, a Delaware corporation (Kaiser Francis), is filing this Amendment No. 8 to its Report on Schedule 13D to report the closing of a recent transaction the effect of which was to change its beneficial ownership of shares of the common stock (Common Shares) of North American Palladium, Ltd. (North American or the Company). Items in Kaiser Francis Schedule 13D (as amended by its Amendment Nos. 1 through 7) that are unchanged are excluded from this Amendment.

This amendment supplements, but does not alter, the earlier disclosures made by Kaiser Francis on its Schedule 13D with respect to North American (the Schedule 13D ) or Amendment No. thereto (Amendment Nos. 1 through 7). Capitalized terms used in this Amendment and not otherwise defined are used as defined in the Schedule 13D and Amendment Nos. 1 through 7.

#### Item 3. Source or Amount of Funds or Other Consideration.

Since the date of Amendment No. 7 to this Schedule 13D, Kaiser Francis has sold approximately 3,000,000 shares of Common Shares for total consideration (net of commissions) of \$16,349,722.16. Additional information regarding such sale is set forth in response to Item 5 below, which information is incorporated by this reference into this Item 3.

#### Item 4. Purpose of Transaction.

Kaiser-Francis incorporates by this reference its answer to Item 3 above.

### Item 5. Interest in Securities of the Issuer.

Kaiser-Francis holds 20.6% of North American Common Shares, consisting of 30,719,824 shares of which Kaiser-Francis has potential sole voting power and sole dispositive power.
