Hsinchu, Taiwan, May 18, 2012 - ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of April 2012.
