## Supplemental Information

Effective November 1, 2008, The Mexico Fund, Inc. (the Fund) adopted authoritative guidance under GAAP which defines fair value, establishes a framework for measuring fair value and expands disclosures about fair value measurements. The Fund has determined that the implementation did not have a material impact on the Fund's financial statements.

This guidance establishes a fair value hierarchy that distinguishes between market data obtained from independent sources (observable inputs) and the Fund's own market assumptions (unobservable inputs).

These inputs are used in determining the value of the Fund's investments and are summarized in the following fair value hierarchy:

Level 1 quoted prices in active markets for identical securities

Level 2 other significant observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.)

Level 3 significant unobservable inputs (including the Fund's own assumptions in determining the fair value of investments)

The inputs or methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities. An investment's level within the fair value hierarchy is based on the lowest level of any input, both individually and in aggregate, that is significant to the fair value measurement.

The following is a summary of the inputs used as of January 31, 2014, in valuing the Fund's assets and liabilities carried at fair value:

**Item 2. Controls and Procedures.**

**Item 3. Equity Shelf Program.**

During the fiscal quarter ended January 31, 2014, the Fund sold 578,368 shares of its common stock through its Equity Shelf Program ( ESP ), with net proceeds to the Fund of \$16,617,317. Under the Equity Distribution Agreement, the commissions paid by the Fund to the sales agent, UBS Securities LLC, amounted to \$214,071 during the fiscal quarter.
