Item 8.01. Other Events.

On May 23, 2014, Comerica Incorporated (the <u>Company</u>), completed the public offer and sale of \$350,000,000 aggregate principal amount of its 2.125% Senior Notes due 2019 (the <u>Notes</u>). The Notes were issued pursuant to an Indenture dated May 23, 2014, between the Company and The Bank of New York Mellon Trust Company, N.A., as trustee (the <u>Indenture</u>). The Notes were sold pursuant to an underwriting agreement, dated May 20, 2014 (the <u>Underwriting Agreement</u>), between the Company and J.P. Morgan Securities LLC and Barclays Capital Inc., on behalf of themselves and the several underwriters named therein.

The Underwriting Agreement, the Indenture and the Form of Global Note for the Notes are attached to this Current Report on Form 8-K as Exhibits 1.1, 4.1 and 4.2, respectively, and are incorporated into this Item 8.01 by reference.

The Underwriting Agreement, the Indenture and the Notes are more fully described in the prospectus supplement, filed with the Securities and Exchange Commission (the <u>Commission</u>) on May 22, 2014, to the accompanying prospectus filed with the Commission on November 19, 2012, as part of the Company s Registration Statement on Form S-3ASR (File No. 333-185042) (the <u>Registration Statement</u>).

The foregoing descriptions of the Underwriting Agreement, the Indenture and the Notes do not purport to be complete and are qualified in their entirety by reference to Exhibits 1.1, 4.1 and 4.2.

This Current Report on Form 8-K is being filed, in part, for the purpose of filing the documents attached as Exhibits hereto as exhibits to the Registration Statement in connection with the issuance of the Notes and such exhibits are hereby incorporated by reference into the Registration Statement.
