RECENT EVENTS: DEREGISTRATION OF SECURITIES

The Registration Statement on Form S-3 (Registration No. 333-171031) (the **Registration Statement**) of TiVo Solutions Inc. (previously referred to as TiVo Inc.), a Delaware corporation (**TiVo**), pertaining to the registration of an unspecified number of securities of (i) TiVo secured or unsecured debt securities, in one or more series, which may be either senior, senior subordinated or subordinated debt securities (**TiVo Debt Securities**), (ii) shares of TiVo preferred stock, par value \$0.001 per share (**TiVo Preferred Stock**), (iii) shares of TiVo common stock, par value \$0.001 per share (**TiVo Common Stock**), (iv) warrants to purchase TiVo Preferred Stock or TiVo Common Stock, (v) warrants to purchase TiVo Debt Securities, (vi) or any combination of the foregoing, to which this Post-Effective Amendment No. 1 relates, was filed with the Securities and Exchange Commission on December 7, 2010.

On September 7, 2016, pursuant to the Agreement and Plan of Merger (the **Merger Agreement**), dated as of April 28, 2016, by and among TiVo Corporation (previously referred to as Titan Technologies Corporation), Rovi Corporation (**Rovi**), TiVo, Nova Acquisition Sub, Inc. (**Rovi Merger Sub**) and Titan Acquisition Sub, Inc. (**TiVo Merger Sub**), Rovi Merger Sub merged with and into Rovi with Rovi as the surviving corporation and Titan Merger Sub merged with and into TiVo with TiVo as the surviving corporation (collectively, the **Mergers**). As a result of the Mergers, Rovi and TiVo each are now wholly owned subsidiaries of TiVo Corporation.

As a result of the Mergers, TiVo has terminated all offerings of TiVo Debt Securities, TiVo Preferred Stock, TiVo Common Stock, or warrants to purchase any of the foregoing securities (collectively, **TiVo Securities**) pursuant to its existing registration statements, including the Registration Statement. In accordance with an undertaking made by TiVo in the Registration Statement to remove from registration, by means of a post-effective amendment, any shares or warrants to purchase any shares of TiVo Securities which remain unsold at the termination of the offering, TiVo hereby removes from registration all shares of TiVo Securities registered under the Registration Statement which remain unsold as of September 7, 2016.
