Voya Financial, Inc. (the Company) is furnishing this Current Report on Form 8-K to disclose the assets under management (AUM) of its Investment Management (IM) segment prior to the availability of the Company's quarterly earnings release and quarterly financial supplement for the quarter ended March 31, 2017, scheduled for release on May 3, 2017.

As of March 31, 2017, AUM of the Company's IM segment was \$213 billion. AUM as of March 31, 2017 included \$76 billion of IM-sourced external client assets, \$55 billion of affiliate-sourced external client assets, and \$82 billion of Company general account assets. External client assets are reported on a market value basis. General account assets are reported on a statutory book value billing basis consistent with revenues earned. On a market value basis, general account assets were \$88 billion as of March 31, 2017.
