**Item 1.01. Entry Into a Material Definitive Agreement.**

As previously announced, on December 5, 2017, Duke Realty Corporation, an Indiana corporation (the Company), and Duke Realty Limited Partnership, an Indiana limited partnership (the Operating Partnership) of which the Company is the sole General Partner, entered into a Terms Agreement (including the related Underwriting Agreement, dated as of June 16, 2016, attached as Annex A thereto and made a part thereof, the Terms Agreement) with each of Barclays Capital Inc., Citigroup Global Markets Inc., RBC Capital Markets, LLC, U.S. Bancorp Investments, Inc., Jefferies LLC and SunTrust Robinson Humphrey, Inc., on behalf of the underwriters named therein (the

Underwriters), pursuant to which the Underwriters agreed to purchase from the Operating Partnership \$300 million aggregate principal amount of the Operating Partnership's 3.375% Senior Notes due 2027 (the Notes). The Terms Agreement was previously filed as Exhibit 1.1 to the Operating Partnership and the Company's combined Current Report on Form 8-K filed on December 6, 2017. The issuance and sale of the Notes was completed on December 12, 2017. The Operating Partnership intends to use the net proceeds from the issuance and sale of the Notes to fund development and for general corporate purposes, and it may use a portion of the proceeds to repay borrowings under its revolving credit facility.

The Notes were issued under the Indenture, dated as of July 28, 2006 (the Indenture), as supplemented by the Fourteenth Supplemental Indenture, dated as of December 12, 2017 (the Supplemental Indenture), by and between the Operating Partnership and The Bank of New York Mellon Trust Company, N.A. (as successor to J.P. Morgan Trust Company, National Association), as trustee (the Trustee).

The Notes were registered with the Securities and Exchange Commission (the Commission) pursuant to the Operating Partnership's automatic shelf registration statement on Form S-3 (File No. 333-203744-01) (as the same may be amended or supplemented, the Registration Statement), under the Securities Act of 1933, as amended (the Securities Act). The material terms of the Notes are described in the Operating Partnership's final prospectus supplement, as filed with the Commission on December 6, 2017 pursuant to Rule 424(b)(5) of the Securities Act, which relates to the offer and sale of the Notes and supplements the Operating Partnership's prospectus, as filed with the Commission on April 30, 2015, contained in the Registration Statement.

A copy of the Supplemental Indenture is filed as Exhibit 4.1 to this Current Report on Form 8-K (this Report), and the information in the Supplemental Indenture is incorporated into this Item 1.01 by this reference. The Indenture was previously filed with the Commission on July 31, 2006 as Exhibit 4.1 to the Operating Partnership's prior registration statement on Form S-3 (File No. 333-136173-01). The above description of the terms of the Supplemental Indenture is qualified in its entirety by reference to the Indenture and the Supplemental Indenture incorporated by reference into this Report.
