Although it has not finalized its full financial results for the fourth quarter and fiscal year ended December 31, 2017, Agios Pharmaceuticals, Inc. (the Company) announced on January 8, 2018, that it expects to report that it had approximately \$568 million of cash, cash equivalents and marketable securities as of December 31, 2017.
