- (1) On March 30, 2005, Harris Corporation distributed a stock dividend, payable to all holders of record of common stock on March 14, 2005, of 1 share of common stock for each share of common stock outstanding. The aggregate of 139,011.68 shares listed in Column 5 of Table I includes shares acquired on 3/30/05 as a result of the 2-for-1 split as well as: (a) 43,000 performance shares previously reported (adjusted to reflect the March 30, 2005 stock split) and subject to adjustment; (b) 50,000 restricted shares previously reported (adjusted to reflect the March 30, 2005 stock split) and subject to vesting; and (c) 14.36 shares acquired through the Harris Corporation 401(k) Retirement Plan from 3/10/05 through 3/30/05.
