RSUs vest one-third on the earlier to occur of March 4, 2009 or the 2009 ABM Annual Meeting of Shareholders; one-third on the earlier to occur of March 4, 2010 or the 2010 Annual Meeting of Shareholders; and one-third on the earlier to occur of March 4, 2011 or the 2011 Annual Meeting of Shareholders.
- (2) Includes 4743 RSUs and 756 shares of common stock that reflect the settlement of one-third of June 13, 2007 RSU grant.
