- (1) Restricted shares granted pursuant to the Invacare Corporation 2003 Performance Plan in an exempt transaction under Rule 16b-3. These shares vest in 25% increments over four years commencing on November 15, 2011.

The reporting person holds previously reported options to buy 164,100 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 1994 Performance Plan and the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between August 24, 2000 and August 19, 2009, at exercise prices between \$20.48 to \$44.30 per share, will expire between August 24, 2010 and August 19, 2019 and became or will become exercisable between September 30, 2001 and September 30, 2013.
