The number of RSUs was determined by dividing \$80,000 by \$46.36, the closing price of the Issuer's Common Stock on the New York Stock Exchange on the day before the grant.
 - (2) Owned by a corporation that the Reporting Person controls. The Reporting Person disclaims beneficial ownership of such 15,000 shares.
 - (3) Represents shares allocable to the outside directors' deferred fee plan account under the Cash America International, Inc. 1994 Long-Term Incentive Plan and the Cash America International, Inc. First Amended and Restated 2004 Long-Term Incentive Plan, as amended, and reflects an adjustment for dividends paid to the Reporting Person pursuant to the dividend reinvestment provisions of such
