- (1) On May 25, 2005, the common stock of the Issuer split 2-for-1, resulting in the reporting person's acquisition of 51,032 additional shares of common stock.
 - (2) The total includes 339 shares acquired by the reporting person on June 30, 2005 under the Issuer's Employee Stock Purchase Plan.
Part of a grant to the reporting person of 30,000 shares from the Issuer's 1995 Stock Plan. The options vested in five annual installments beginning 2/12/99. This option was previously reported as covering 15,000 shares at an exercise price of \$23.69 per share, but was adjusted to reflect the stock split on May 25, 2005.
 - (3) Part of a grant to the reporting person of 30,000 shares from the Issuer's 2000 Stock Plan. The options vested in five annual installments beginning 2/10/01. This option was previously reported as covering 15,000 shares at an exercise price of \$29.81 per share, but was adjusted to reflect the stock split on May 25, 2005.
 - (4) Part of a grant to the reporting person of 15,000 shares from the Issuer's 2000 Stock Plan. The options vested in five annual installments beginning 2/9/02. This option was previously reported as covering 7,500 shares at an exercise price of \$38.03 per share, but was adjusted to reflect the stock split on May 25, 2005.
 - (5) Part of a grant to the reporting person of 18,000 shares from the Issuer's 2000 Stock Plan. The options vested in five annual installments beginning 2/07/2003. This option was previously reported as covering 9,000 shares at an exercise price of \$33.73 per share, but was adjusted to reflect the stock split on May 25, 2005.
 - (6) Part of a grant to the reporting person of 15,000 shares from the Issuer's 2000 Stock Plan. The options vested in five annual installments beginning 8/14/03. This option was previously reported as covering 7,500 shares at an exercise price of \$32.50 per share, but was adjusted to reflect the stock split on May 25, 2005.
