(1) Disposed of pursuant to merger agreement between issuer and CPI International Acquisition, Inc. (formerly Catalyst Holdings, Inc.) in exchange for \$19.50 per share in cash.

(2) This option provided for vesting in three equal annual installments: one-third vested on the day before each of the first, second and third annual stockholders meetings occurring after the date of grant. The option was cancelled in exchange for a cash payment equal to the excess of the amount payable for shares in the merger (\$19.50) over the exercise price, resulting in a net payment of \$2.41 per option.
