On December 1, 2008, an irrevocable trust under a trust agreement between the Reporting Person s mother, Barbara P. Ruhlman, and Bernard L. Karr, dated July 29, 2008, acquired from Barbara P. Ruhlman one million Company Common Shares. As business advisor to the trust, the Reporting Person has dispositive and voting authority with respect to the Company Common Shares owned by the trust.

The Reporting Person will have shared voting and dispositive power of 1,493,764 Common Shares, including 93,312 shares held in trust for the benefit of Randall M. Ruhlman and his children (these 93,312 shares are also shown as being beneficially owned by Robert G. Ruhlman), 400,452 shares held in the Ethel B. Peterson Trust of which KeyCorp is the trustee and for which Randall M. Ruhlman acts as co-Trust Advisor and has voting control (these 400,452 shares are also shown as being beneficially owned by Robert G. Ruhlman) and 1,000,000 shares held in the Irrevocable Trust between Barbara P. Ruhlman and Bernard L. Karr of which Bernard L. Karr is the trustee and for which Randall M. Ruhlman acts as co-Trust-Advisor and has voting control (these 1,000,000 shares are also shown as being beneficially owned by Robert G. Ruhlman).

- (d) The Reporting Person, based on his percentage ownership of the Common Shares to which this statement relates, has the right to receive or the power to direct the receipt of dividends from, or the proceeds from, any sale of such Common Shares. The Reporting Person holds interests that exceed 5% of the Common Shares.
