If the threshold is achieved, the corresponding performance vesting will occur on the third day after the issuance of the issuer's next press release publicly reporting quarterly or annual financial results.
- (3) Represents options to purchase common stock granted under the issuer's 2006 Equity and Performance Incentive Plan.
