The reporting persons acquired beneficial ownership of 41,719,614 shares of the Issuer's common stock pursuant to the Agreement and Plan of Merger, dated 10/5/06 (the "Agreement"), by and among Global Signal Inc. ("Global Signal"), the Issuer and CCGS Holdings LLC. Each of the reporting person's Global Signal shares were exchanged for either 1.61 shares of Crown Castle common stock or \$55.95 in cash, at each stockholder's election and subject to proration as described in the Agreement. On 1/19/07, certain of the reporting

- persons entered into a Stock Purchase Agreement (the "SPA") with the Issuer, pursuant to which the Issuer agreed to purchase from such persons an aggregate of 11,042,424 shares of the Issuer's common stock for \$374,027,428.86. The closing of the transactions contemplated by the SPA is expected to occur on 1/26/07. Upon the consummation of such transactions, the reporting persons will hold the shares of the Issuer's Common Stock that are the subject of this Form 3.
