(1) The Series A Convertible Preferred Stock were issued upon the conversion of the 9% senior secured notes of the Issuer's wholly-owned subsidiary which were owned separately by each of Mr. Andrews and Mr. Andrews jointly with his spouse. Mr. Andrews converted \$258,250 of interest and principal of the senior notes, and Mr. Andrews jointly with his spouse converted \$154,950 of interest and principal of the senior notes.

(2) The Series A Convertible Preferred Stock is not convertible into Common Stock until shareholder approval, and the subsequent filing, of an amendment to the Issuer's charter, which, once effective, makes available a sufficient number of authorized but unissued and unreserved shares of the Common Stock to permit all then outstanding shares of Series A Preferred Stock to be automatically converted.
