On August 1, 2014, MeetMe, Inc. (the "Company") issued a press release announcing that the underwriters of its recent public offering of common stock have exercised their option to purchase an additional 750,000 shares of common stock at the public offering price of \$2.00 per share. In connection with the offering, the Company has sold an aggregate of 5,750,000 shares of its common stock for aggregate net proceeds of approximately \$10.5 million, after deducting the underwriters' discount and other offering expenses.
