On September 20, 2017, Transocean Ltd. (the "Company") announced that a subsidiary of Chevron elected to exercise its contractual option to terminate the drilling contract for the ultra-deepwater drillship Discoverer Clear Leader, effective November 2017, prior to its expiration in October 2018. In accordance with the contract terms, the Company will be compensated through a lumpsum payment of approximately \$148 million.
