- (1) On October 1, 2012, under the Spectrum Brands Holdings, Inc. 2011 Omnibus Equity Award Plan, Mr. Matthews was awarded 2,632 restricted stock units which are settled in shares of common stock of the Issuer, and which are scheduled to vest in full on September 30, 2013 if Mr. Matthews is a director of the Issuer on such date.
