(1) Restricted stock units convert to common stock on a one-for-one basis.

The restricted stock units vest in four equal annual installments with the first installment vesting on March 4, 2015. Settlement will occur on each such vesting date, and the shares of common stock will be transferred to the reporting person no later than 30 days after such date, subject to certain exceptions in the Restricted Stock Unit Agreement between the Issuer and the reporting person.

(2) The restricted stock units vest in four equal annual installments with the first installment vesting on March 5, 2016. Settlement will occur on each such vesting date, and the shares of common stock will be transferred to the reporting person no later than 30 days after such date, subject to certain exceptions in the Restricted Stock Unit Agreement between the Issuer and the reporting person.

(3) The restricted stock units vest in four equal annual installments with the first installment vesting on March 4, 2017. Settlement will occur on each vesting date, and the shares of common stock will be transferred to the reporting person no later than 30 days after such date, subject to certain exceptions in the Restricted Stock Unit Agreement between the Issuer and the reporting person.

(4) These options were granted on January 1, 2010 and vested 20% on each of the first five anniversaries of the grant date. These stock options became fully vested on January 1, 2015.
