Sabby Management, LLC, a Delaware limited liability company, indirectly owns 900,000 common shares because it serves as the investment manager of Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies. Mr. Mintz indirectly owns 900,000 common shares in his capacity as manager of Sabby Management, LLC.
